### RULES OF THE COMPETITION

What are the Hack&Match events:

The "Hack&Match" events represent **a smart, easy and quick way to help European SMEs willing to answer needs or to scale market opportunities to find potential concrete ideas and solutions adopting Advanced Technologies through 2 consecutive days teaming-up with tech-savvy SMEs and/or technological experts in Europe.**

#### Organiser

The IDEALIST project, funded under the Horizon Europe programme of the EU (HORIZON-CL4-2023-RESILIENCE-01 call), represents a strategic initiative aimed at bolstering the resilience and technological adaptability of Small and Medium-sized Enterprises (SMEs) within the European Union and beyond.

IDEALIST's primary goal is to **empower SMEs** in three key industrial ecosystems: **Energy-Intensive Industries, Aerospace and Defence, and Mobility, Transport, Automotive**. These sectors are crucial to the European economy and face shared challenges, such as transitioning to sustainable practices, competitiveness in a context of limited raw materials and rising energy costs and adapting to changing consumer habits.

IDEALIST's effort will empower SMEs across Europe **to foresee their future actively, embrace advanced technologies, and mitigate supply chain vulnerabilities.**

The IDEALIST consortium brings together 14 partners from 7 countries, including innovation clusters, a knowledge community, a foresight specialist, and a tech centre. United by the mission to foster industrial ecosystems, we aim to enhance SMEs' innovation, support Ukraine's reconstruction, and strengthen EU integration.



## The focus of the Hack&Match #3:

In order to **unlock the Power of Technology-Driven Energy Efficiency** and **start the journey toward smarter, greener, and more profitable operations powered by technology**, the third Hack&Match focuses on the **“Advanced Technologies for Energy Savings”**.

## Eligibility of participants

The Hack&Match events are meant to boost European SMEs through the use of Advanced Technologies for Energy Savings. The participants can therefore be:

### CHALLENGE PROVIDERS:

- SMEs (including start-ups)
- Mid-Caps
- Large companies

### SOLUTION PROVIDERS:

- Tech-savvy SMEs, start-ups
- Researchers
- Technology centres
- EDIH, Digital Innovation Hubs
- Accelerators and other similar scale-up organisations.

Participants don't need to be/have been involved in the project's other actions to participate in this Hack&Match event.

## How does it work?

1) **CHALLENGE PROVIDERS APPLY FROM SEPTEMBER 1<sup>st</sup> 2025 TO OCTOBER 3<sup>rd</sup>, 2025:** Any eligible organisation is invited to submit through the dedicated form one or more challenges (needs) which it is facing and would like to find solutions at the moment.

2) **THEN WE WILL LAUNCH A "CALL FOR SOLUTIONS" FROM OCTOBER 6<sup>th</sup> TO NOVEMBER 7<sup>th</sup>, 2025:** We will invite organisations throughout Europe to team-up with you to help you find one or more solutions to the needs submitted.

3) **THEN WE WILL INFORM BOTH TYPES OF APPLICANTS ABOUT THE COMPOSITION OF THEIR TEAM AND SEND THE INSTRUCTIONS TO JOIN:** They will be informed **FROM 10 TO 14<sup>th</sup> NOVEMBER, 2025**.

4) **GET PREPARED FOR COLLABORATING TO SOLVE NEEDS - SAVE THE DATES FROM NOW:** The Hack&Match event will run **from NOVEMBER 18<sup>th</sup> to 19<sup>th</sup>, 2025** in **100% online mode**.

Participants must ensure their presence at least in these moments:

- **18 NOVEMBER - From 9:00 to 10:30:** Kick-Off Meeting - Expert Key-note Speech on Artificial Intelligence - Presentation of the teams - Explanation of the rules and working modalities



# IDEALIST

- All discussions and collaborations will be possible in online Teams on AGORA platform, segmented according to where the **18 NOVEMBER - From 10:30 to 11:30:** Team-up - Reciprocal presentations - Explain carefully the needs and expectations - Start finding one or more solutions. Start drafting the slides and word document to explain the solution. Agree with your Solution Provider(s) the next online meeting times to develop the solution.
- **19 NOVEMBER - By 15:30** the participants must return to the organisers the 2 deliverables explaining the solution(s) developed.
- **19 NOVEMBER - From 16:00 to 17:30:** Organisers' recap of the solutions of each Team.

The Teams will be composed by **minimum 2 and maximum 8 persons**, including representatives of the Challenge provider, of the Solution Provider(s) and the Tutors. During the Hack&Match period, the defined Teams will exchange and define innovation challenges, mainly based on expressed needs, and try together to find and deliver at least one idea/solution.

The IDEALIST partners will act as Tutors to help the participants achieve the most effective participation and results before and during the Hack&Match event.

As a follow-up of the Hack&Match event, and according to your answers and inputs during the Hack&Match phase, we will help you connect with further SMEs which want to find solutions and innovate on the same topics, also with readily-available solutions. That kind of cooperation in a later phase might grow into beneficial business relations.

## Why should you participate?

Participating in the IDEALIST Hack&Match events represent:

- for traditional European SMEs – and also larger ones – operating in the target industrial ecosystems an opportunity to get an overview of the different Advanced Technologies that can be implemented in their companies to develop new features/innovations in their products/services, increase productivity, reduce costs, develop new digital business models and facilitate their green transition
- for tech-savvy SMEs, an opportunity to promote their solutions/knowledge and open-up new potential collaboration
- for any other organisation, an opportunity to co-develop ideas and promote partnering opportunities.

## Modality of participation: Links

Registration will take place in two waves:

- **From September 1<sup>st</sup> to October 3<sup>rd</sup>, 2025 → Call for Challenges** about the Hack&Match topic “Advanced Technologies for Energy Savings”

More than one entry per company, with different participants, is allowed per company both for the Call for Challenges and the Call for Solutions.



Any incomplete entry containing false information or not meeting the criteria defined in these rules will not be considered if the organisers decide.

The participants will then receive an email from IDEALIST confirming their participation in the event.

The costs (human effort, etc.) incurred by the participants to participate in the Hack&Match event remain at their own expense.

The IDEALIST partners will organise by themselves the competing Teams according to the answers to the registration form. The Organisers can change the Teams at any time during the event, if deemed suitable to ensure a quality result for the participants.

All the work on the project should be done during the Hack&Match time. The Teams can use an idea they had before the event. The Teams can work on a statement that they have worked on before. In such a case, the participants must clearly define what was previously developed and newly created. Adding new features to existing projects is allowed. However, the Jury members will only consider new functionalities or features added during the Hack&Match in determining the winners.

The Teams can receive advice and support from the IDEALIST Tutors during the 2 days of the Hack&Match.

**Two (2) deliverables** will be asked to the Teams at the end of the event:

- 1 application form (text document, 3 pages maximum) presenting – according to a given template – which problem the Team decided to solve, presentation of the solution, its benefits, how to implement the idea, etc.
- 1 presentation (powerpoint document, 5 slides maximum) summarizing the concept of the solution.

More information about deliverables and awarding criteria will be given to all participants at the beginning of the event.

## And the winner is...

A European Jury composed by IDEALIST partners and expert third parties not having been directly involved in the Hack&Match will evaluate the solutions submitted by the Teams.

The Jury members will reward **the most innovative and valuable idea** in relation to the IDEALIST project's objectives. Scoring will be based on several criteria which will be communicated to the participants during the event.

After determining the winner, the Jury will also award **a special "Coup de Coeur" prize** to a second Team whose work has caught the attention of most Jury members.

The results will be announced online during the Awarding Ceremony of IDEALIST Hack&Match #3 following a deliberation meeting with the Jury members.

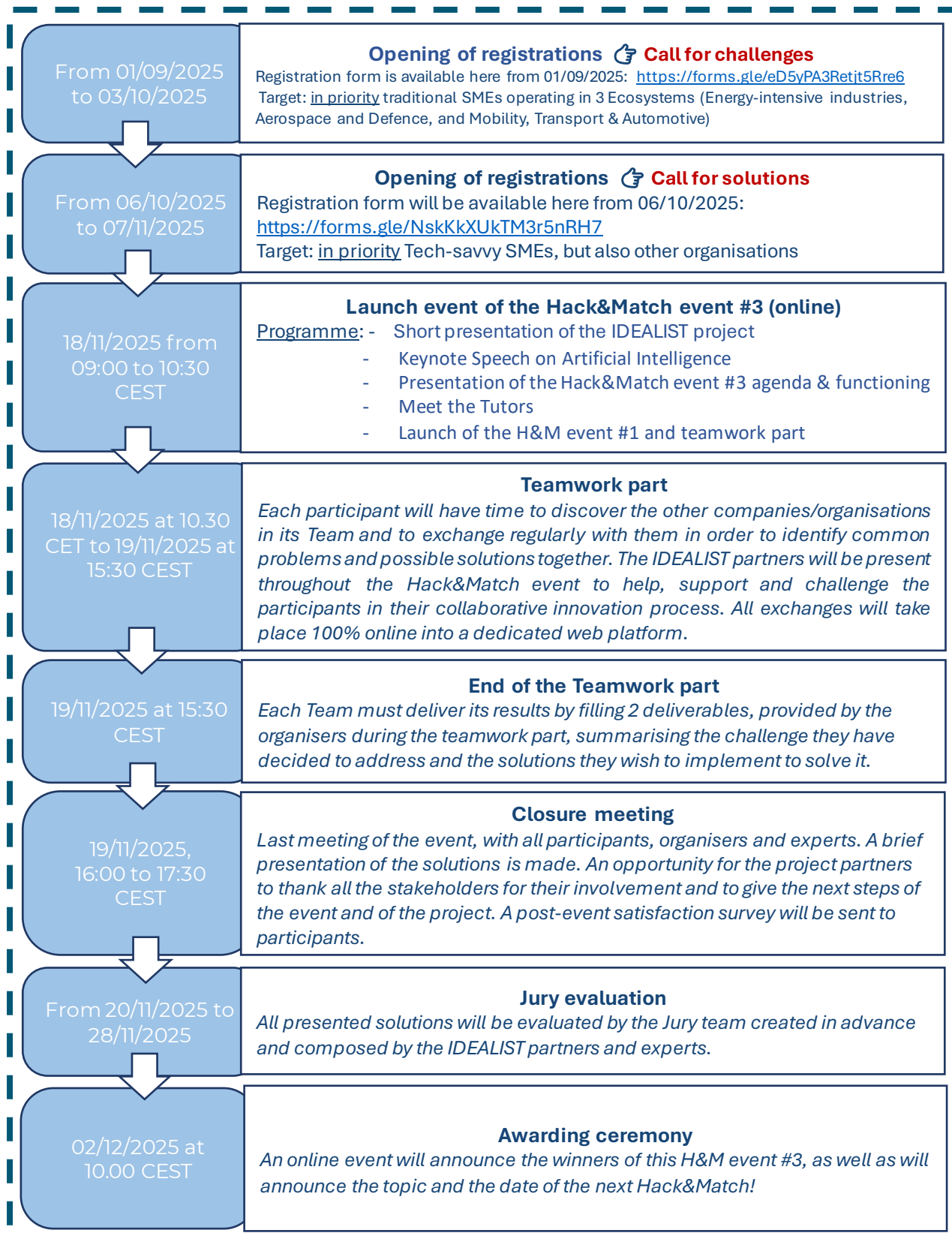
The decisions of the Jury members are final and without appeal.

The participants promise to produce, during the competition, creations that comply with the laws and regulations in force in Europe and over which they alone hold the rights. Furthermore, the participants guarantee, in particular to the organisers, against any act of counterfeiting and fraudulent use of intellectual property rights owned by third parties.

All participants retain all intellectual property rights to their intellectual and material creations developed by Hack&Match event.

By registering, the participant authorizes the organisers, free of charge and 5 (five) years, to exploit, and in particular to distribute, reproduce and exhibit its image, fixed by all means and on any medium, including photographic or video, made during the event as part of their internal and / or external communication, and especially on social networks where the organisers are present.

## Responsibility

Participation in the competition is the whole responsibility of the participants.

The organisers cannot be responsible if one or more participants cannot connect when registering. Similarly, the organisers cannot be responsible if one or more participants cannot participate in the Hack&Match event due to any technical fault or problem linked to an impediment or congestion of the network.

The organisers reserve the right to cancel the Hack&Match event #3, shorten it, extend it, postpone it, or modify the conditions at any time if required. However, they shall not be held liable in this respect.

The organisers cannot be responsible for any damage, material or immaterial, which may be caused directly or indirectly to the participants, their property, and their computer equipment and/or data stored there during the event.

## GDPR & personal data

The contact details of any person who registers and participates in the Hack&Match event will be collected and processed electronically. In accordance with the art. 13 Regulation EU n. 679/2016 as in force, the persons wishing to participate are informed that the communication of their contact information is mandatory for the validation of the participations (failing this, the participation will be considered as null and void) and that they are only communicated to the organisers, for the only purpose of the competition and of the project Reporting. The participants, particularly the winners, authorize the organisers to publish or disseminate their first and last names on their communication media.

## General regulations

Registration and participation in the Hack&Match event imply full acceptance of the eligibility conditions and the terms and conditions of participation in the competition. Registration and participation in the competition also imply full acceptance of these rules.

The organisers will decide any difficulty relating to the interpretation or application of these rules without appeal. Any registration or participation that does not comply with these rules or with the spirit of the competition can lead to a deletion of the award.

The organiser reserves the right to cancel or modify these rules for reasons dictated by internal or external circumstances or force majeure. In the event of a pure and simple cancellation, no charge of any kind may be made against the organiser. In the event of a change to these rules, the organiser undertakes to inform the candidates of the content of the rules at the latest two weeks before the assessments are held.

Any dispute concerning one or more points in the rules and any dispute arising from this competition will be decided without appeal after deliberation by the Jury.
